- Successful bidder may require to make approved sample from concern programme before delivery. In case of sample submission, sample(s) must be returned within 7 working days from email notification. Otherwise, sample(s) will be disposed.

**f) Offer Validity:** 30 days from the date of submission .

**g) Evaluation:** Evaluation will be done on the basis of Lot.

**h) Payment:** Payment will be transferred to your company bank account directly within **45 days** after satisfactory delivery and a notation on the delivery challan by the recipient (with name, designation & date). The supplier must mention his A/C Name, Account No., Bank Name, Branch Name and e-mail address in the Invoice / Bill through a seal. The supplier must provide Mushok 6.3 along with bill as per govt. rules.

The vendor must submit their latest PSR copy; otherwise, 50% extra AIT will be charged as per government rules (e.g., if the AIT is 5% of the billing amount, it will be 7.5% instead for non-submission of the latest PSR copy).

**i) Partial Payment** against partial delivery is allowed.

**j) Depending** on the final requirements; the quantity shown may be increased or decreased by up to 15% and this shall be reflected in the purchase order.

**k) Alternative Offer:** Alternative offer will not be accepted

**l) Child Labor:** Vendors shall comply with locally applicable law regarding child labor.

**m) Only one** organization can participate in the bidding process under the same proprietorship. If found more than one organization under the above condition, both the organizations will be termed as non-responsive.

**n) During** the participation in any tendering/enlistment process, if any vendor provides fake document, they will be banned from business with BRAC for certain years as per BRAC Procurement Guideline

**o) If there** is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail.

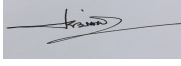
